- 1. Reference is made to office of Transport Commissioner, Uttarakhand advertisement No. 415/Niyojan/13-235/2023 dated 08.02.2023 vide which expression of interest/Application were invited from willing operators to establish at stations at various locations in Uttarakhand state.
- 2. In the ibid advertisement dated 08.02.2023, Earnest Money deposit amounting to 5 lakh per location was sought along with tender /application processing fee of Rs 5000/- per EOI.
- 3. Reference is also made to corrigendum reference No. 561/Niyojan/13-325 dated 25 Feb 2023 vide which EOI were amended after considering the oral and written objections/suggestions by the interested parties in the pre bid meeting held on 16.02.2023.
- 4. That in the para 2 of corrigendum dated 25.02.2023, the term "Bank Draft" in column 3 at Sl. No. 1 of the advertisement dated 08.02.2023 is being replaced by "Bank Guarantee" in the corrigendum dated 25.02.2023.
- 5. That the applicant seeks the following clarification/objections:
 - (a) The format of bank guarantee is not given in both the advertisement and the corrigendum.
 - (b) The Corrigendum is silent about the name of beneficiary for the transfer of bank guarantee.
 - (c) The Corrigendum does not provide the office address of the department in which the process fee of Rs. 5000/-per EOI to be submitted.
- 6. That in the case of United India Insurance Co Ltd vs. Orient Treasures (P) Ltd (2016) 3 SCC 49, it was held that each and every word in a tender must be given in meaning, for it being a serious exercise and TEC can not evolve its own cretiria to evaluate the eligibility of bidders, contrary to the terms and conditions of the tender.
- 7. That in Tata Cellular vs. UoI (1994) 6 SCC 651, it was held that the tender flouting authority was the best person to interpret the terms of the tender but the said authority cannot act arbitrarily, whimsically or contrary to the terms and conditions of the tender.
- 8. That after the issue of corrigendum dated 25.02.2023, applicant visited in person to the office of the transport commissioner, seeking the clarification in terms of para 4 of this application, but there is no authentic reply received by the applicant.
 - That applicant has also E mailed his grievances and also telephonically contacted the related persons, but there is no reply received.
- 9. That there is now only few days left for the tender closing, hence applicant is writing to you. It is also rumored that the tender is just a formality, the allocation is already finalized. This is a clear cut bias. The applicant will have to approach appropriate forum in case of no redressal from your office.




