Sub : Supreme Court Committee on Road Safety (SCCoRS) -Monitoring and review of Road Safety measures as per directions of the SCCoRS.

Ref: DO Letter No.05/CoRS/2022 dated 06.12.2022 from the Chairman, Supreme Court Committee on Road Safety, addressed to the Hon'ble Chief Minister of Uttarakhand State.

Sir,

Kindly refer to the letter dated 6th December, 2022 written by the Chairman, Supreme Court Committee on Road Safety to the Hon'ble Chief Minister of your state (a copy of the same is attached herewith).

2. In accordance with para 6 of the above referred letter and the directions of Chairman, SCCoRS, the undersigned is now in the process of finalizing his annual programme of visits to each State in the country as per directions of the Chairman, SCCoRS. It is, therefore, requested that the 03 convenient dates for the visit may be given latest by 15.01.2023. The tentative Agenda during the visit shall be as follows:

- i) A formal interaction with the Lead Agency Officers of the State with a view to sensitize the public awareness about road safety programmes;
- ii) Present status of the implementation of the SCCoRS directions in the State;
- iii) Implementation of the revised Rules & Regulations of the M.V. Act, 2019;
- iv) Any unique and specific problems being faced by the State in implementation of SCCoRS directions for road safety;
- v) Future plans of the State for the next 03 years for reduction in road accidents and resulting fatalities; and
- vi) Any other points/issues which the State may discuss and bring to the notice of the SCCoRS for road safety.

3. In this regard, a Questionnaire designed by SCCoRS for holistic assessment of the road safety measures covering 4E's (i.e., Engineering, Enforcement, Education and Emergency Care) is also enclosed herewith which may be kept ready with supporting documents at the time of the undersigned's visit.

4. Accordingly, it is requested to revert back with proposed dates of visit as requested above, so as to enable the SCCoRS to finalise the schedule of visit to the State.
